The B.A.F. have very strict rules governing:

- 1) The relationship between first and second claim members.
- 2) The procedures governing resignation from an athlete's first claim club.

In order to register with the B.A.F. Sudbury Court Running Club has to draw prospective member's attention to the following:

The B.A.F. rules state: "A notice of resignation must be made in writing and shall be considered by the Club within one calendar month of receipt. Membership shall be deemed to have ceased on the actual date of the tendering of the notice, unless the member be financially indebted to the club, in which case the acceptance shall be withheld until the indebtedness has been met. The date of resignation shall then be the date on which the debt was discharged.

After 28 days from ceasing to be a member of a Club or Association athletes shall not be eligible to compete in Open Competition until they have again become members of an affiliated Club or Association.

Athletes may apply to their Regional or National Association as appropriate, that their membership of a Club shall be deemed to have ceased as from two years since the payment of the appropriate annual subscription of that Club, provided that they not represented the Club in any competition during that period of two years.

HARDSHIP EXEMPTION; Any athlete who wishes to claim exemption from the operation of any of the rules relating to first claim membership or eligibility shall apply to the Region in which the Headquarters of the Club the athlete wishes to represent is situated. The athlete shall state the grounds upon which exemption is claimed and supply any further information that the Committee may require. Such grounds may include a move of residence, or the inadequate provision of facilities for training or competition.....or the agreement of both clubs concerned to the move"
